

Notice on Upcoming Domestic and Sexual Violence Training

Dear members,

In order to assist nurses to meet the requirements of relicensure, the MNA is offering a DPH approved training on Domestic and Sexual Violence, presented by a DPH approved trainer. MGL c 260, §9 of the Acts of 2014 requires the boards of registration in medicine, nursing, nursing home administrators, physician assistants, social workers, psychologists and allied mental health and human services to promulgate regulations establishing standards that require training on the issue of domestic and sexual violence as a condition of licensure and license renewal.

The program will be offered across the state in a live face to face format. As with all MNA educational programs, a \$25 placeholder fee is required and will be returned to MNA Members at check in. Domestic and Sexual Violence Training: What Nurses Should Know

Description: This presentation will look at the dynamics of domestic and sexual violence, the health impact of violence and abuse, and the consequence of children's exposure to violence. The role of the nurse will be explored to include trauma-informed care. This three hour program had been approved to meet the BORN re-licensure requirement for mandatory education on Domestic and Sexual Violence Training (MGL c 260-9).
