

Emergency Medical Response to Hazardous Materials and Acts of Terrorism

Course Objectives: The Massachusetts Emergency Management Agency (MEMA) is sponsoring this program on Emergency Medical Services in response to Hazardous Materials and acts of Terrorism. The program is specifically designed for Physicians, Nurses and EMTs, and Hospital Support Staff to provide education in the treatment of individuals exposed to chemical and biological agents. Program will include identification of hazardous materials, toxicological and biological effects of chemicals and biological acts of terrorism. The chemical profile of common agents, the decontamination procedures, the personal protective equipment will be discussed. CDC Guidelines for surveillance of exposed nurses and other healthcare workers and nursing interventions for patient care will be identified. Class size is limited to 25 participants per session. From Logan International Airport : Take Sumner Tunnel to I-93 S ("Southeast Expressway") to Rte 128 N. Take Exit 2A (Stoughton) onto Rte 138 S.

From Boston: Take I-93 S (Southeast Expressway) to Rte 128 N. Take Exit 2A (Stoughton) onto Route 138 S.

From Cape Cod/South Shore: Take Route 3 N to where the road splits to Boston. Stay left and follow I-93; I-95 South-Dedham. Take Exit 2A (Stoughton) onto Route 138 South. Route 188 is Turnpike Street.


From the North: Take Rte 128 S which is also I-95 S. (At the split of Rte 128 S and I-95 to Providence stay on Rte 128 S, at this point 128 S becomes I-93). Take Exit 2A (Stoughton) onto Rte 138 S.

From the West: Take Mass. Pike East to Rte 128 S toward Cape Cod. (At the split of Rte 128 S and I-95 to Providence stay on Rte 128 S, at this point 128 S becomes I-93). Take Exit 2A (Stoughton) onto Rte 138 S.

From Turnpike Street: Drive approximately 2 miles. (You will pass through two traffic lights) Take a left at the billboard which reads 320-348 Turnpike Street, Enterprise Car rental is on the corner. Follow the road, which curves to the right. You will see the brick Massachusetts Nurses Association building. The MNA is on the second floor.
