- **Board of Directors Updates:** Dominique Muldoon was appointed as Vice President of the MNA. Carla LeBlanc was appointed to the vacant Region 2 seat that expires in 2025. - Steward Health Care filed for Chapter 11 bankruptcy Monday, May 6<sup>th</sup> in Houston. All of the Steward hospitals (31) in the U.S. are to be sold. They put forth a plan to sell the Texas and Arizona hospitals first followed by the Ohio, Pennsylvania and Massachusetts hospitals and the last group is Florida. We will continue to keep Steward members informed.
- Negotiations continue at Brigham & Women's, Brigham and Brigham & Women's Faulkner, Clinton Hospital, Dana Farber, Marlborough Hospital and Tobey Hospital.
